## CLGC Seeking Nominations for Officers

To be nominated, a member must have a current glider rating, and must have been a member of the council for at least one year.

As you consider potential nominees, a formal description of the Director Responsibilities as defined in the By-laws.... followed by my own albeit myopic perception of what the job *really* entails:

### **PRESIDENT**

"Preside over each monthly meeting. Coordinate monthly meeting program.

Assist other officers in their respective responsibilities. Call Board of Directors meetings as necessary. Uphold Council's goals and Bylaws."

*90% of this job is planning the monthly meetings—and 90% of that job is securing speakers and presentations. Curt has done a great job in coercing volunteers to bring forward some really interesting subject matter in the last couple of years—often in the face of last minute changes and cancellations. Curt has also taken on development and maintenance of the new Web site.*

### **VICE PRESIDENT**

"Preside over monthly meeting in President's absence. Attempt to maintain and increase Council membership. Bring refreshments to each monthly meeting."

*Chuck Spreitzer has been kind enough to take on the refreshments obligations for as long as I can remember—one less "to-do" for the Veep. And Curt's attendance record has been very good at monthly meetings. John DeRosa serves as a good sounding board for many of the Board's action and activities. John has also taken on the un-official task of being the AV specialist at our meetings.*

### **TREASURER**

"Maintain Council checking account. Receive dues and disburse payments for Council authorized business. Provide new members and renewed members names to the person who is maintaining Council membership list."

*I'm sure John Harrison gets more mail than any other CLGC board member—what with all those \$10 checks crammed in his mail box each January. John maintains an Excel spreadsheet with all sorts of interesting data about each of you—and sends the Secretary an updated version each month with current address, e-mail preferences, and dues payment information used in producing the Newsletter mailing list.*

## Nominations Con't SECRETARY

“Make informal record of monthly meetings. Publish and mail monthly (October through April) to be in members hands on or about one week prior to scheduled monthly meetings. 

## SSA Update

The CLGC works because of volunteerism. Similarly, volunteers work even harder to look after our sport on a regional, national, and international scope. Jim Short’s summary of recent SSA activities is reprinted here, with permission of Steve Wasilowski—our Region 7 Director.

From SSA Chairman Jim Short, what follows is a summary of SSA and Excom activities over the last three weeks:

**Search Committee:** The Search Committee has been formed consisting of: John Volkober, Steve Wasilowski, Tim Welles and Karol Hines along with Steve Northcraft as the responsible Excom member. The committee has had two phone meetings and some information is already up on the web page. This is a massive and important job, so please give this group your best cooperation. If you have questions, the focal point is Karol Hines.

**WGC 2006.** Although the news may not be posted by the time you read this, the SSA bid for the Internationals in 2006 was edged out by Sweden. Steve Northcraft worked very hard on the presentation as did the others at the meeting, Eric Moser (our primary delegate), Hannes Linke, Bernald Smith and Larry Sanderson.

**Young Eagles Insurance Approved.** After considerable research, on top of what had been done last year, SSA purchased insurance so SSA clubs, schools and individuals can participate in the EAA Young Eagles promotion this year. The insurance is a new requirement of which SSA just became aware last year. In order to continue as a partner with EAA on this program (SSA was the first such organization to partner with the EAA on the Young Eagles program several years ago) SSA must purchase special liability insurance, which this year cost \$2,000. John Campell of the Youth Committee has offered to publicize this program so as many local clubs, schools, sites and individuals as possible can continue with this program this year.

**Trips to Hobbs.** The week after Larry Sanderson's resignation, Chip Garner visited the staff at Hobbs in person to reassure them during this time of turmoil for them. His trip helped the office morale, especially at a time that was so close to Larry's departure. Last weekend, Jim Short also visited Hobbs for extended talks with Alan Gleason and Jim Kashner. This trip gave Jim the impression that Alan and his staff can handle the regular processes of the SSA in a very capable manner until candidates can be found for the Executive Director and the Director of Member Services and Relations jobs. Most of the regular staff functions are well organized, and with a little coaching from Directors when they need something, the Hobbs Staff should handle the current processes very well. Jim's assessment is that interim external help is definitely not necessary at this time.

Please work with the staff, especially if they may not be well briefed on projects on which you are working as a volunteer. Also, please remember that the staff is smaller now that it has been for decades, so be patient if your request is not handled immediately.

**Bottom line:** During this transition year, be patient and understanding with our staff and be careful about how much of their time you request. Work with your state governors and directors before calling Hobbs.
